# **Summary and Recommendations**

#### Recommendation(s):

- (a) To note the licence fees set by statute.
- (b) To agree the licence fees set by the Council for 2008/9 as laid out in this report.
- (c) To consider letters from the Adult Industry Trade Association and from Simply Pleasure in connection with the level of fees for sex establishments.

#### Introduction

1. Executive Board has agreed fees and charges for 2008/9 as set out in Appendix 1. The table includes a number of licences where the Council has discretion to set its own level of fees. The general principles when setting fees are that they must be reasonable and relate to the cost of performing the function. Costs include staffing, administration, testing, inspections, hearings, enforcement and appeals.

#### **Sex Establishment Licences**

- 2. Letters have been received from the Adult Industry Trade Association and from Simply Pleasure seeking a reduction in these fees. (Appendices 2 and 3.)
- 3. The Council adopted the provisions of the Local Government (Miscellaneous Provisions) Act 1982 in 2003 when the third sex shops opened in Oxford. The fees were initially set at £5,000 for an application for grant or renewal, and £500 for a transfer. Fees have been increased annually and in 2007/8 were set at £6,500 and £1,050. The proposed fees for 2008/9 are £7,750 for an application for grant or renewal, and £1,080 for a transfer.

# **Financial Implications**

4. The Council is responsible for collecting licence fees for these functions. Predicted income from licence fees is included in the Council's budget.

## **Legal Implications**

5. The General Purposes Licensing Committee's responsibilities are set out in the Council's Constitution and include setting and reviewing licensing fees.
