1. ELECTION OF CHAIR FOR THE 2007/08 COUNCIL YEAR

2. ELECTION OF VICE-CHAIR FOR THE 2007/08 COUNCIL YEAR

Councillor Turner was elected Vice-Chair of the Committee for the 2007/08 Council Year.

4. DECLARATIONS OF INTEREST

6. APPOINTMENT OF SUB-COMMITTEES FOR THE 2007/08 COUNCIL YEAR

 - (d) Objections to applications for or changes or transfers of premises licences Casework Sub-Committee
 - (e) Objections to provisional statement applications Casework Sub-Committee
 - (f) Premises licence reviews Casework Sub-Committee
 - (g) Objections to club gaming/club machine permit applications Casework Sub-Committee
 - (h) Cancellation of club gaming/club machine permits Casework Sub-Committee
 - (i) Counter notice to a temporary use notice Casework Sub-Committee
 - (j) Objections to prize gaming permit applications Casework Sub-Committee
 - (k) Any other functions that may not be delegated to officers or that require a hearing Casework Sub-Committee
 - (I) All other functions under the Act Environmental Health Business Manager

- (2) In respect of items (g), (i) and (j) in the Scheme of Delegation, to alter the powers and duties of the Casework Licensing Sub-Committee (agreed in Minute 6) to accord with the Scheme, as follows:-
 - (a) delete item 5 and insert the following:-
 - "5. To decide whether to prevent temporary events or uses when there are objections".
 - (b) delete item 10 and insert the following:-
 - "10. to deal, when there are objections, with applications for club gaming or club machine permits, and with cancellation of such permits."
 - (c) delete item 11 and insert the following:-
 - "11. to deal, when there are police objections or officers are minded to refuse, with applications for prize gaming permits."

9. STATEMENT OF LICENSING POLICY

The Head of Legal and Democratic Services reported that Council had adopted its Statement of Licensing Policy under the Licensing Act 2003 on 16th December 2004. The Policy committed the Council to review the Policy at intervals of not more than 3 years. The Committee's meeting timetable did not fit with the timetable that would see the adoption of the revised policy by Council on 19th November 2007. He therefore suggested a revised timetable of meetings.

Resolved:-

 - 17th July 2007 to approve a consultation draft of a revised Statement of Licensing Policy (noting that if a licensing hearing was needed on that day, the start time would need to be rearranged)
 - 24th October 2007 to agree a revised Statement of Licensing Policy for recommendation to Council on 19th November 2007
- (2) In consequence of (1) above, that the Committee should meet on its scheduled date of 12th September 2007 only if there was business to warrant holding a meeting;
- (3) To note that the remaining dates when the Committee would meet were 16th January 2008 and 8th May 2008.
