Introduction

 This report informs Committee of progress made by the Licensing Authority under the duties of the Licensing Act 2003 and Gambling Act 2005 between November 2007 – April 2008. Under Policy GN10 of the Statement of Licensing Policy, the Licensing Authority should report to the Committee on matters determined by Licensing Officers with delegated authority. 2. The report covers data on service volumes; details of Licensing hearing decisions and decisions made by Officers with delegated powers; information on TENs; latest closing times of premises; and enforcement activity.

3. The table below provides data on licence applications received during the period April 2007 – March 2008.

4. To date the Licensing Authority have processed; 921 Personal Licences; 602 New Premises Licences; 101 Variations on Premises Licences; 58 Premises Transfer Applications and 72 New and Variations of Club Certificates.

Applications Granted by the Licensing Authority

5. A hearing is not required where an application has been lawfully made and no Responsible Authority or Interested Party has made a representation. In these cases, the Licensing Authority must grant the application in the terms sought, subject only to conditions which are consistent with the operating schedule and relevant mandatory conditions in the Act. There were 24 licences issued by the Licensing Officers under delegated authority, details are listed in Appendix 1.

Representations and Licensing Sub-Committee Hearings

- 6. When Relevant Representations are received from Interested Parties or Responsible Authorities then the application is determined at a Licensing Sub-Committee Hearing. If the applicant decides to agree additional conditions with the Responsible Authority the representation can be withdrawn and a hearing may no longer be required.
- 7. Relevant Representations were received for 6 applications for Premises Licenses and Club Certifications, resulting in hearings.

Reviews of Licensed Premises

- 9. Under the Act it is possible for the Authority to review a Premises Licence at any time if a Representation from a Responsible Authority or a Relevant Representation from an Interested Party is received. The Authority has no powers to initiate its own review. Reviews may only arise in connection with a failure or failures in the premises connected to the licensing objectives.
- 10. During November 2007 and April 2008 there were three applications for Premises Licences Reviews that were determined by the Licensing Committee. The details of these reviews can be found in Appendix 3.

Enforcement Activity

12. Between November 2007 and April 2008, the two Licensing Officers have made:

- 64 Inspections on Premises
- Issued 62 warning letters to premises (predominantly for licences not displayed on the premises)
- 13. Most inspections are carried out as a result of a complaint, following intelligence, or in connection with an application. A risk based inspection programme is being developed for all licenced premises and will be the subject of a future report to Committee.

14. The Licensing Authority in partnership with Thames Valley Police have agreed an Enforcement Ladder for Licensed Premises. If a licensed premises fails to be managed in a responsible manner it will be introduced to the Enforcement Ladder. The Licensing Authority and Thames Valley Police will do everything possible to assist and work with the licensee to remove the premises from the ladder. This document can be found in Appendix 4.

Temporary Event Notices (TEN's)

15. An action arising from the last Licensing and Gambling Acts Committee on the 16th of January 2008, was for the Licensing Authority to provide the Committee with details of TEN's held by ward for the period of April 2007 – March 2008. The document can be found in Appendix 5.

Test Purchasing

16. A joint test purchasing operation was carried out with Licensing Officers and Thames Valley Police on Friday 25th April.

- 17. The fail rate for this Operation was particularly high at 44%. Two teenagers were used in the operation and attempted to purchase alcohol from the premises. The persons who sold the alcohol to the teenagers were instantly issued a fixed penalty notice for £80.
- 18. The Licensing Authority will hold formal interviews with the Designated Premises Supervisors for each of the outlets that failed the test purchasing operation to investigate why the alcohol was served/supplied. The Authority will also give advice on how to take measures to prevent underage sales. Coverage of the test purchase operation was reported in the Oxford Mail and published on Oxford City Council's website, a copy is attached in Appendix 6.

<u>Matters Arising from Licensing and Gambling Acts Committee – 16th</u> January 2008

- 19. The Committee requested the Authority to provide details of latest closing times for Licensed Premises . These details can be found in Appendix 7.
- 20. At the request of the Committee under the Licensing Act 2003, the Authority have produced a guidance leaflet for local residents in Oxford. The leaflet includes how to object to a premises licence application and how to initiate a review of an existing licence. The leaflet was launched with a press release and distributed to Area Committee meetings. Copies of the press release and the guidance leaflet can be found in Appendices 8 and 9.
