

**Premises Licenses Granted Under Delegated Authority**

**1. The Ultimate Picture Palace, Jeune Street, Oxford, OX4 1BN**

Application granted for:

Variation of Premises Licence application. Extension of licensable hours for regulated entertainments, sale of alcohol and late night refreshment. Conditions agreed between applicant and Thames Valley Police.

**2. Grays Road Stores, 2 Grays Road, Headington, Oxford, OX3 7QA**

Application granted for:

New Premises Licence application: The previous Licence holder has passed away, so a new application has to be made. There will be no change to the activities or times to the previous Licence, just a change of licence holder (namely the previous Licence holder's Widow) and Designated Premises Supervisor.
