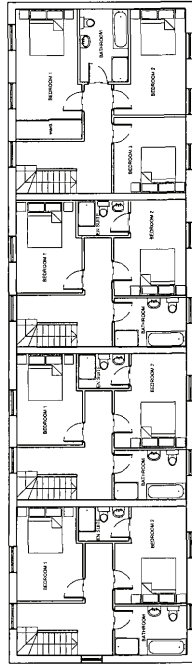

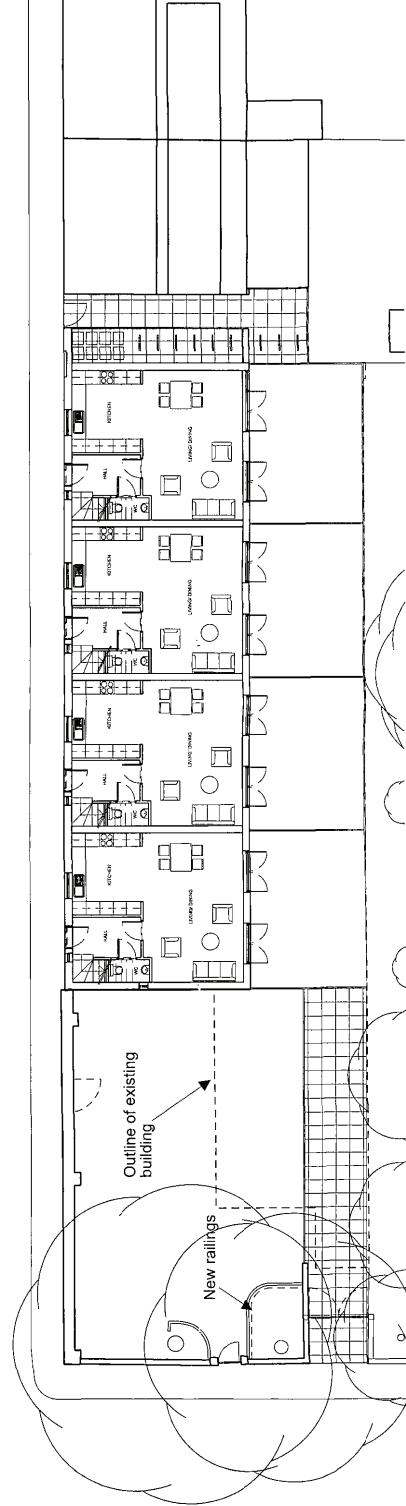
SECOND FLOOR PLAN

WEST ELEVATION



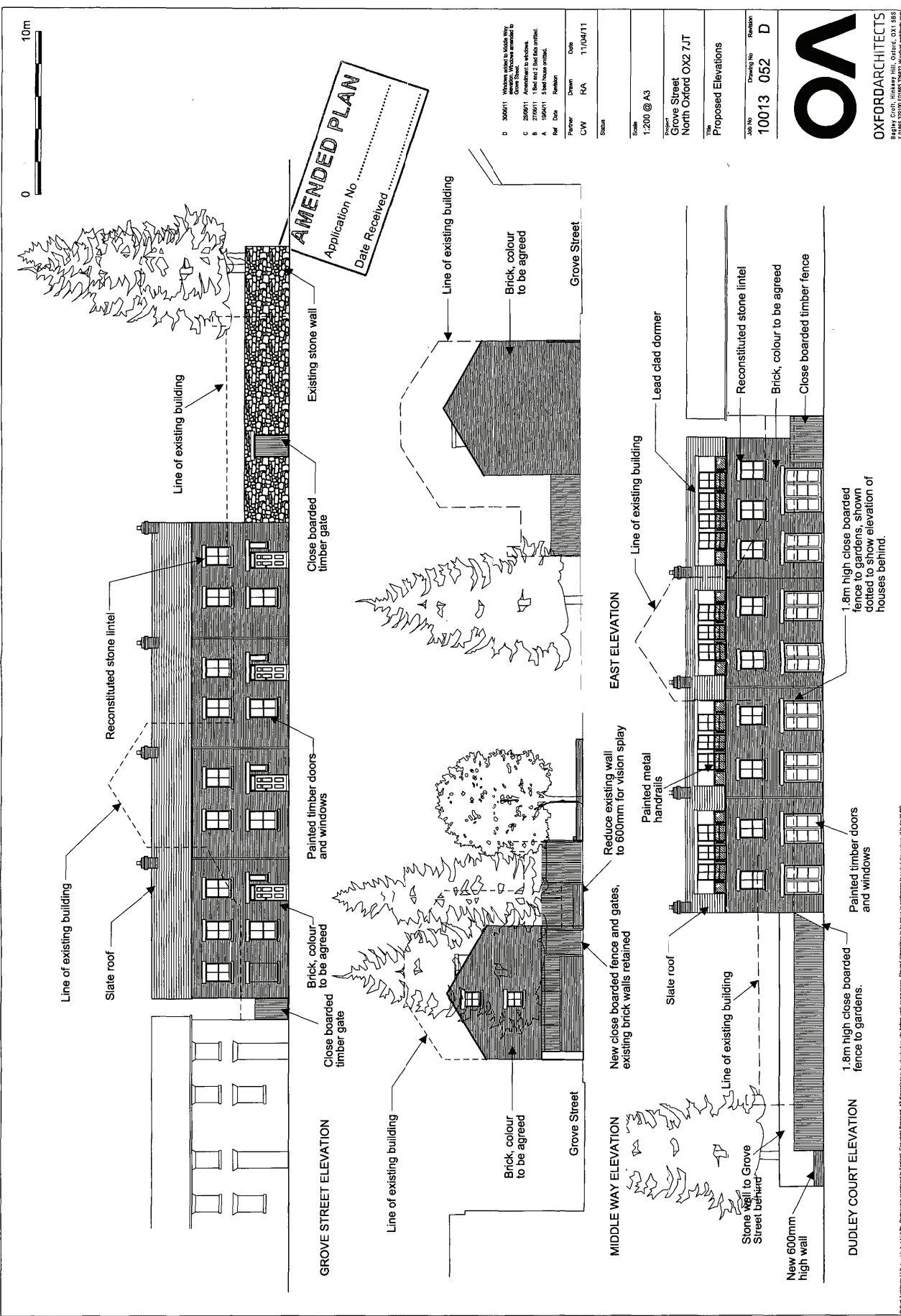

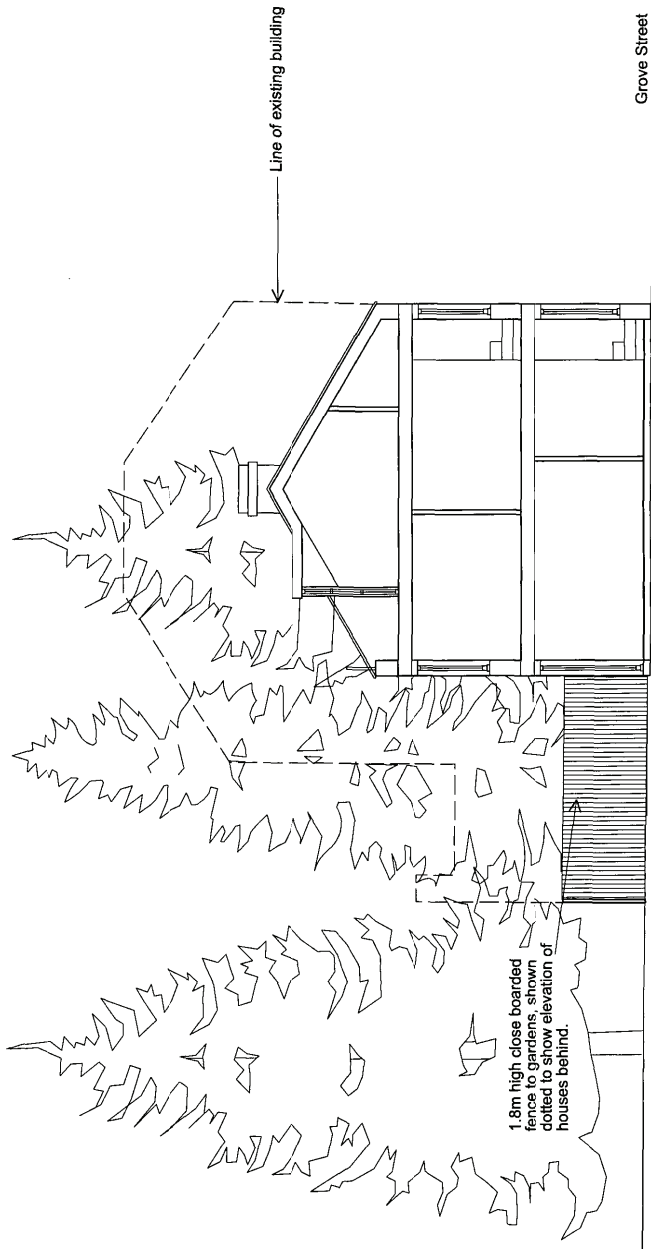
