Restrictions on Committee Memberships

- ❖ Disciplinary Committee – must include at least one Board member
- ❖ Appointments Committee – must include at least one Board member
- ❖ Planning Committees East and West – no councillor may be a member of more than one planning committee
- ❖ Planning Review Committee – a member of this committee may not be a member of either of the two area planning committees
- ❖ Scrutiny Committees – No Board member may be a Scrutiny Committee member. The Council must appoint at least one Scrutiny Committee.
- ❖ Licensing and Gambling Acts Committee – members on this committee should be sufficiently available to serve on licensing casework panels that meet reasonably frequently (at 5.00 pm on Thursdays). This Committee does **not** have to be politically balanced. This committee must be appointed by Council.

Political Balance

The principle that the proportion of the total number of seats on the total of all committees are allocated to the same proportion to the full Council takes precedence over the principle that the number of seats on each Committee are allocated in the same proportion to the full Council.
