Proposal: Alterations to window at ground floor level on north

elevation to incorporate door and installation of staircase from new fire exit door down to ground floor. Removal of existing spiral staircase and metal mesh enclosure from south elevation and installation of new dog-legged staircase from first floor to ground floor with metal mesh enclosure at ground floor level. Increase width of fire exit door openings onto the existing staircase at first, second and third floor levels. Re-configure door openings to rear of ground floor offices, infill one door opening, increase width of remaining

door opening and fit new fire exit.

Issues:

Design and conservation area Vehicle access

Officers Assessment:

Site description

- Oxford City Council's office building at St Aldate's Chambers has four storeys
 plus a basement. While the main entrances for staff and the public are from
 St Aldate's, there is vehicle under-croft access from St Aldate's to the south of
 the building into New Inn Yard. This access is shared with the adjoining
 properties to the south of the building.
- 2. The building has various exits on the west, south and north elevations, including exits on first, second and third floors on the west elevation leading onto the fire escape staircase.
- 3. See **Appendix 1** for site plan.

Proposal

4. Various external changes are proposed to the building to upgrade the means of escape from the building.

Design and conservation area

- 5. The alterations and additions proposed are not readily visible from the public realm, and do not substantially alter or harm the appearance of the building. They are considered to preserve the appearance of the Central conservation area. The existing mesh enclosure will be replaced by a single-storey mesh enclosure which, although it will cover a larger area, will be less over-bearing than the existing arrangement. The materials proposed will match the existing; a condition relating to materials is recommended.
- 6. The proposal is therefore considered to comply with policies CP1, CP8 and HE7 of the Oxford Local Plan, and policy CS18 of the Oxford Core Strategy in terms of design and impact on the conservation area.

Vehicle access

7. The additions to the north elevation will not impact vehicle access because this area is only used by bicycles and motorcycles and ample space will remain.

- 8. Although the new dog-legged staircase with mesh enclosure will occupy a larger footprint than the current spiral staircase, these will be located within land owned by the applicant and not on shared access land. Sufficient width will be retained for vehicles in New Inn Yard.
- 9. The proposal is therefore considered to comply with policies CP1 and CP10 of the Oxford Local Plan in terms of vehicle access.

Conclusion:

Officers recommend that Committee approves the application.

Human Rights Act 1998

Officers have considered the Human Rights Act 1998 in reaching a recommendation to grant planning permission, subject to conditions. Officers have considered the potential interference with the rights of the owners/occupiers of surrounding properties under Article 8 and/or Article 1 of the First Protocol of the Act and consider that it is proportionate.

Officers consider that the conditions are necessary to protect the rights and freedoms of others and to control the use of property in accordance with the general interest. The interference is therefore justifiable and proportionate.


