## Grants to Voluntary and Community Groups 2005/06. Part B.

Area Committees have been considering grant recommendations from applicants in the February cycle of meetings. Officer recommendations have been accepted at Cowley and North. North East and East area have not yet met at the time of writing. Executive Board are advised that South East and Central South West area committees have disagreed with some of the grant recommendations

committees have disagreed with some of the grant recommendations submitted. Minutes from both meetings are attached below.

The current grants process is based around a central operated budget which any eligible Oxford City organisation can apply to, therefore the allocation is made to the applicant organisation and not by geographical or ward area. Allocation is based on applications received rather than the assumption that Area Committees have part of the grants budget to allocate as they wish.

The impact of Area Committees allocating more than has been recommended or reallocating amongst applications being considered could result in overspending or unsound decisions.

This issue has usefully highlighted that there needs to be clarification and clear guidance on future decision making on grants. This will be addressed in the grants review that will inform decisions from 2006/07 onwards.

In the meantime Executive Board is requested to indicate whether it wishes to agree with the comments from the Area Committees as attached or follow officer recommendations.

### **GRANTS TO VOLUNTARY AND COMMUNITY GROUPS 2005/2006**

The Neighbourhood Renewal Business Manager submitted a report (previously circulated and now appended).

Committee noted the recommendations in the report, and made the following comments:

(1) Item 6.2 Blackbird Leys Art Club. Councillor Craft stated that the IWCA opposes giving a grant to the Blackbird Leys Art Club.

(2) Item 6.9. Oxford Blackbird Football Club. Councillors Craft and Smith expressed concern that funding had not been allocated to this project.

(3) Item 6.10 Rose Hill and Littlemore Young People's Project – Councillors felt that the Youth Service should be supporting this project and asked that the funding bid be referred to Executive Board for consideration (4) Item 6.11 Rose Hill Community Centre. Councillors questioned that the £6,000 that was stated as a carry forward figure was still in hand as it was understood that it had been spent on the Easter Playscheme. Paul Isaacs, Community Centre Area Manager confirmed there were no reserves. Councillors recommended that an additional £1450 be made available for the applicants.
