What action needs to be taken?

Variation of authority previously given at Executive Board on 26th April 2004 to reflect a change in the agreement with Primesite Media about the provision of trolley's and advertising at Gloucester Green.

A report was submitted to EB by Graham Smith, Business Manager of Transport and Parking detailing a proposal to enter into an agreement with an advertising company who would provide the City Council with luggage trolleys for use at Gloucester Green and a rack in which these luggage trolleys could be stored. Advertising would then be permitted on the side of both these trolleys and the rack. The Advertising Company would have retained ownership and been responsible for the maintenance of the trolleys.

The proposal has now been changed (upon advice from the Council's legal department) to indicate that the advertising company will pay a sum of money (£2000 in the first year and £1000 per year thereafter) to the City Council out of which trolley's can be purchased. The trolleys will be owned and maintained by Oxford City Council.

There is an additional proposal that the Advertising Company will supply a taxi waiting shelter for use by customers at the taxi rank. The Company will then use the sides of the shelters for advertising panels.

Why does this need to happen?

It is important that the Council does not enter into agreements with third parties unless properly authorised to do so. As there was a change in the proposal this change needs to be noted by Members.
