Purpose of report: This report reviews the current management of trees in Oxford City Council and highlights the fact that to und ke the work specified the Council will have to approve a budget increase as part of Final 2006-07 to 2008-09 budget, because there is no budget provision for this extra work. This report is background information to a budget bid.

1. Tree Numbers in Oxford			

1.1 Leisure and Parks have undertaken an assessment of the number of trees under the ownership/management of Oxford City Council (Table 1).

1.2 The trees itemised in Table 1 have never been inspected or maintained in their lifetime which presents an unknown liability to the City Council.

# 2. Proposal

- 2.1 To undertake a comprehensive tree survey of all trees under City Council management/ownership.
- 2.2 To focus on trees that have as yet not been inspected specifically including;
  - a. Allotments (L&P)
  - b. Cemeteries (L&P)
  - c. Ecological sites (L&P)
  - d. Housing estate areas (HSNG)
  - e. Housing properties (HSNG)
  - f. Commercial land (F&AM)
  - g. Asset management owned properties (F&AM)
- 2.3 Highway trees are being effectively and intensively managed under the current arrangement and it is not proposed to include these in this survey.
- 2.4 The survey would be undertaken by the private sector through a process of open tender.
- 2.5 The results would be captured and stored on the tree management database.
- 2.6 The findings would include conditional comments about trees and the specifying of any necessary work, along with a priority for that work and an individual risk assessment of the tree.
- 2.7 The data would be collected on hardware, which would need to be procured as part of the process.

2.8 If budget approval is given for this then a Major Project Approval report will also need to be produced

## 3.Benefits

3.1 The benefit to Oxford City Council of undertaking a large-scale survey will be that;

- a. The City Council would be working in line with best practice and within principles generally accepted by industry specialists as the way to undertake large scale tree management;
- b. The survey would be completed within an acceptable timeframe;
- c. The data collected would allow comprehensive planning and resourcing for the short to medium term;
- d. Risk management principles would be closely managed and followed;
- e. Reduction in overtime and call out payments as a result of improved tree management.
- f. Increased levels of safety in Oxford.

## 4. Financial implications

- 4.1 To undertake a comprehensive assessment of 87395 trees the cost is estimated at £213k dependent on a satisfactory tendering exercise.
- 4.2 Other costs would include;
  - a- £15k for hardware and software to allow data capture.
  - b- £60K for short term employment of an arboriculturist to carry out day-to-day management of the tree service, to allow for adequate supervision of the contractors undertaking the survey.
  - c- £213k for the carrying out of work, which becomes necessary as a result of the survey.
  - d- £20k to acquire a suitable system for locating/positioning trees.

## 5. Project management

- 5.1 It is proposed to undertake this survey within two years from successful letting of the contract.
- 5.2 The survey would generate a significant amount of work, which will be equal to the amount of money spent on the survey.
