106. ORGANISATIONAL CHANGE POLICY, RETIREMENT POLICY AND DISCRETIONARY PAYMENTS

The Head of Human Resources submitted a report (previously circulated and now appended). The Head of Human Resources proposed the following amendments to the report as submitted:

- Organisational Change Policy paragraph 10 (second line down on page 3.12) delete "No" at the beginning of the sentence so it reads "Reference will be made"
- Retirement Policy page 3.29 paragraph 4(d) ILL HEALTH RETIREMENT second line and penultimate line insert "approved by the Council" after "independent Occupational Health Advisor" in both places.
