# 📜1. Background

1.1. The Community Scrutiny Committee requested an update on the new European Social Fund (ESF) round and the Council's potential involvement

- in bids at their meeting on 15<sup>th</sup> November (a copy of the report is attached as Appendix 1)
- 1.2. The new ESF round was launched in September and its two priority areas are around: extending employment opportunities and developing a skilled and adaptable workforce. Oxford has been identified as a priority area for extending employment opportunities to workless adults.
- 1.3. The report noted that the Council does not have experience of leading bids of this nature and therefore this could compromise the success of the bid.
- 1.4. The Chief Executive and Strategic Directors made a decision to work with other partner organisations rather than to lead on any particular bids.
- 1.5. Cllr David Williams stated at Community Scrutiny on 10<sup>th</sup> November that he had a great deal of experience in applying for European Social funding and was willing to assist officers free of charge to make the best possible bids.
- 1.6. The Committee endorsed this offer and stressed the importance of the City's full involvement in the bid process to ensure the needs of the city were adequately addressed.
- 1.7. Cllr Williams agreed to contact the Chief Executive with this offer of help and support. The Committee were disappointed to note that this offer had been declined.
- 1.8. It is understood that funding deadlines for the European Social Fund 2008 11 will end in early February. However Cllr Williams offer was to help the City Council look at the feasibility of other sources of European Funding too.
