#### 284. APOLOGIES FOR ABSENCE

#### 286. PUBLIC QUESTIONS

#### 287. OXFORD 2026 – THE CORE STRATEGY FURTHER PREFERRED OPTIONS

The Head of City Development submitted a report (previously circulated and now appended).

#### Resolved that: -

- (1) the Further Preferred Options document for Oxford's Core Strategy be approved for public consultation;
- (2) the Planning Policy Manager be authorised to make any necessary minor editorial corrections to the Core Strategy Further Preferred Options document;
- (3) it be noted that there was a need for bus companies in Oxford to

implement orbital as well as radial bus routes in order to facilitate ease of access between sites outside of the City Centre.

# 288. PEERS SCHOOL – COUNTY COUNCIL CONSULTATION ON LAND DISPOSAL

The Area Co-ordinator (South East Area Committee) and the Interim Strategic Director for City Regeneration submitted a joint report (previously circulated and now appended).

#### Resolved that: -

- (1) The comments of the South East Area Committee set out below be forwarded to the County Council as part of Oxford City Council's response to the consultation: -
  - The Area Committee did not support the proposal for housing on this site, as there was already little open space within the area;
  - The Area Co-ordinator had been asked to investigate a previous land use survey to ascertain what proportion of land in the area could be defined as "open space";
  - It be noted that the sale of this piece of land was not in support of the Peers Academy, as stated in a letter from Mouchel, but was to support the redevelopment of Mabel Pritchard School;
  - There was a right of way across the proposed housing site, and this should be preserved.
- (2) The proposals must be seen not just in the context of providing the best for education, but also what is best for the local community and the City as a whole. They must balance educational needs against the needs of a sustainable community, with wide-ranging community and cultural activities (including provision of facilities for young people), and provision of more affordable housing without the loss of leisure facilities or green space.
