1. Introduction

1.1 In 2006 Executive Board accepted recommendations of a review of the grants process, designed to make it more open, seen to be fair, deliver strategic goals and be value for money.

1.2. The key recommendation was to separate the decision making on the priorities from decisions on which organisations to fund. This was to be achieved by producing an annual prospectus setting out what type of activities the City Council will fund.

2. 2009/2010 Grants Programme Prospectus

2.1 The grants budget is deployed to support strategic Council priorities. This report is requesting approval for the 2009/2010 grants prospectus that follows the City Council's core priorities as outlined in the Corporate Plan for 2008-2011. Appendix 1 to this report comprises the proposed grants prospectus for 2009-2010.

3. Consultation

- 3.1 The draft 2009/2010 grants programme prospectus has been out for consultation for 6 weeks.
- 3.2 We received a 20% return from the 115 consultation questionnaires posted out to Community and Voluntary groups. Appendix 2 to this report provides a breakdown of feedback received.

4. Budget Allocation

4.1 The budget agreed for the 2008/2009 grants programme is £1,633,759. It is envisaged that this will remain the same for the financial year 2009/2010 with no increase for inflation.

This budget is divided into two sections:-

- Commissioning (approx 91%)
 Oxford City Council will commission with organisations that provide a service that contributes directly to the council's priorities and aims.
- Open bidding (approx 9%)
 Applications will be invited to apply for funding through the open bidding section for specific projects that fall within broad themes and contribute indirectly to the council's priorities and aims.

5. Area to be commissioned (see appendix 1 for full details)

- 5.1 Lead officers will manage the relationship with each of the organisations to be commissioned with, negotiating the appropriate grant payment and leading on monitoring and evaluation of the services each organisation provides.
- 5.2 From the beginning of the financial year 2008/09, organisations falling into the following categories were commissioned with for 3 years.
 - Homelessness
 - CVO infrastructure
 - Arts Programme
 - Twinning projects
- 5.3 Where possible the remaining categories will be commissioned for two years. In 2011/2012 all commissioned funding arrangements will be reviewed and where appropriate organisations will be recommissioned.
- 6. Open Bidding (see appendix 1 for full details)
- 6.1 The remaining balance of £134,564 is allocated as follows:-

•	Open Bidding	£109,564
•	Small grants	£5,000
•	Emergency grants	£10,000
•	Arts Development grants	£10,000

7 Members' Involvement

7.1 Due to wide member interest in the grant process, a training session has been arranged and will be held on 20th October 2008 to familiarise members with the process and criteria for making grants decisions. Area committees will be consulted on the recommendations at the January/February 2009 cycle of meetings

8. Climate Change Implications

8.1 Thought has been given to climate change and its impacts.

Organisations may apply for funding for projects which protect and enhance Oxford's built and natural environment and these will be considered alongside other applications. All successful applicants will be reminded of the city council's corporate plans to cut emissions and reduce the impact of climate change, and will be encouraged to develop similar plans of their own.

9. Risk

9.1 In order to manage any risks to the grants process a timetable has been prepared and is attached for information as appendix 3 to this report.

2009 - 2010

Introduction

Oxford City Council has traditionally funded voluntary and community groups, as part of building stronger and more inclusive communities in our city.

This prospectus sets out which activities Oxford City Council will fund in the financial year 2009-10, both through commissioning and through open bidding. Organisations can apply for grants of up to and including £15,000 in the open bidding section.

Oxford City Council wishes to prioritise funding for activities that contribute to the corporate priorities of the city council, as set out below.

- More housing, better housing for all
- Stronger and more inclusive communities
- Improve the local environment, economy and quality of life
- Reduce crime and anti-social behaviour
- Tackle climate change and promote environmental resource management

It particularly welcomes applications for projects that provide added value to existing or new provision, through joint commissioning or partnership working. The council does not wish to replace or duplicate other organisations' responsibilities or funding.

For clarity, Oxford City Council will NOT fund:

- Party political promotion or activities
- Activities which promote a religious viewpoint
- Retrospective funding for project costs that have already occurred or commenced.
- Individuals (unless art development projects)
- Projects where there is a commercial gain
- Capital items or tangible "things", such as goods or equipment
- Projects that do not primarily benefit Oxford City residents (e.g. projects that are Oxfordshire county-wide and do not show specifically how they benefit residents of the city)
- Activities where a more appropriate funding source exists or which are functions that are the responsibility of other public agencies, for example:
 - After school clubs and extended school activities
 - o Childcare, unless it is part of a larger project
 - Play and activities targeting over 13s, unless they contribute to reducing antisocial behaviour and crime
 - o Social care

You may wish to refer to Oxford City Council and other local plans and strategies in your application, to demonstrate how your project will fulfil their aims too. All these plans are available on the City Council website or in hard copy from the Grants team.

Oxford City Council recognises the contribution that settled and appropriate accommodation for all our citizens can make to community safety. Our intention is to continue to fund a range of services including hostels, day care centres, floating support and employment and training opportunities.

In the main, these services would receive funding from a variety of funding streams, including HSSD and Supporting People, and wherever possible we will co-ordinate our spending with those agencies to generate value for money and enhance levels of service for our citizens.

24. OXFORD CITY COUNCIL GRANT PROSPECTUS - 2009/2010

The Head of Community Housing and Community Development submitted a report (previously circulated, now appended), which was presented by Julia Tomkins (Grants and External Funding). The Committee also welcomed Councillor Antonia Bance (Board Member for Social Inclusion and Young People).

Councillor Bance informed the Committee that the Grants Prospectus was subject to the budget process, and the timetable shown in appendix 3 had moved on since the agenda was produced – she would circulate the revised timetable following the meeting. There was less money available for the open bidding section of the grants process, as more emphasis was being placed on commissioning, but the total amount of funding available, including for equality issues, had not been reduced.

Councillor Murray observed that there was a need for transparency around the commissioning process, and that there should be clear information available to help applicants to understand this. The Chair, Councillor Rundle, added that the criteria for commissioning needed to be stated and well-known, with transparency around the groups that were commissioned and those that were not. He felt that there should be a place for Councillor involvement in this process to ensure openness, and he questioned the means by which Area Committees, for example, could be involved.

The Chair then highlighted the following issues of concern arising from the discussion:-

- The move from open bidding to commissioning;
- The lack of decision making at Area Committees last year each Area Committee could nominate a delegate to attend a Member Steering Group on grants, but that was not taking place this year;
- The recognition that the grants process always presented a challenge, but there was a continued need to see how the process could be improved;
- Greater involvement of Councillors would be useful.

Resolved to ask the City Executive Board to look at a process for greater involvement by Members in the commissioning and evaluation of grants, noting that the Communities and Partnership Scrutiny Committee particularly recommended the formation of a Steering Group with membership drawn from each Area Committee.
