1. Introduction

- 1.1 The purpose of this report is to identify a need for Oxford City Council to adopt an operational Play Policy, detailing how play provision, play values and principles are practised within Oxford City.
- 1.2 By committing to a Play Policy, Oxford City Council will be able to adopt a good practice commitment to the children and young people of Oxford and provide a set of clear values and objectives that can be agreed on and may enable Oxford City Council to obtain additional external funding to achieve its goals.

2. Background

- 2.1 In August 2005 a Green Space Study was completed which provided an assessment of the quantity, quality, and value of all green space in Oxford including play facilities
- 2.2 The Oxford City Green Space Study incorporated several different assessments including
 - (a) An assessment of the supply of open space through a quantitative audit.
 - (b) A quality audit of sites
 - (c) An assessment of value, which considers the wider role of the site within its local context, level and type of use and the wider benefits.
 - (d) Evaluation of current needs for open space through consultation
 - (e) An estimate of possible future demand and the establishment of a hierarchy of green space provision to meet this need.
- 2.3 As part of the Green Space Study it was highlighted that provision of play facilities would need to be improved and the approval for a programme of the refurbishment of play areas was approved in January 2009,
- 2.4 Oxford City Council has also signed up to the Greenspaces GreenSTAT project, which is a system that gives local residents the opportunity to comment on the quality of their open spaces, which include play areas
- 2.5 Oxford City Council Children and Young Peoples plan 2006-09 also identifies some of the challenges that children and young people in Oxford face with the rest of the county.
- 2.6 The Play Policy is based on the Playlink Policy, which has been adopted by various other local authorities. Playlink.org.uk
