**Subject:** Report on Oxford Sports Council

The Sports Council provides grants to sports clubs, teams and individuals to help them improve and succeed when representing Oxford. Among those it has helped in recent years are Nathan Douglas, the Oxford-born Olympic long-jumper and triple-jumper. It also organises annual Town v. Gown contests in a range of sports, which provide an important opportunity for networking between sportsmen and women in the city. It holds an annual awards ceremony, which is another way in which financial assistance can be channelled to deserving sports organisations.

The Sports Council obtains its income from the squash courts in the Ferry Leisure Centre, which it built. The city council takes the money for use of the courts and passes an agreed amount to the sports council. There have been quite reasonable complaints by the sports council about their being ignored by the city council during changes to the arrangements for managing leisure in the city.

The Sports Council also comments on behalf of sportspeople in the city on relevant planning applications, strategies and plans, and participates in partnerships which are working to increase the level of sporting activity in the city.
