Summary and Recommendations

Purpose of report: To agree write-off of debts in excess of £5,000 for temporary accommodation debts. The cases submitted for write off are presented in accordance with the debt write off policy agreed by Executive Board on 5th April 2004.

1. Introduction

The cases submitted for write off are shown below, indicating the type of write off, the reason and the amount.

In all cases, the Council has attempted to recover the debt, but it has not been able to collect the sums due. All debts were incurred in excess of a year ago, some considerably earlier. The prospects of recovery of the sums due are now considered to be minimal, and that it is uneconomic to pursue these cases further.
