### **DECLARING INTERESTS**

### **General duty**

You must declare any disclosable pecuniary interests when the meeting reaches the item on the agenda headed "Declarations of Interest" or as soon as it becomes apparent to you.

### What is a disclosable pecuniary interest?

Disclosable pecuniary interests relate to your employment; sponsorship (ie payment for expenses incurred by you in carrying out your duties as a councillor or towards your election expenses); contracts; land in the Council's area; licences for land in the Council's area; corporate tenancies; and securities. These declarations must be recorded in each councillor's Register of Interests which is publicly available on the Council's website.

### **Declaring an interest**

Where any matter disclosed in your Register of Interests is being considered at a meeting, you must declare that you have an interest. You should also disclose the nature as well as the existence of the interest.

If you have a disclosable pecuniary interest, after having declared it at the meeting you must not participate in discussion or voting on the item and must withdraw from the meeting whilst the matter is discussed.

### Members' Code of Conduct and public perception

Even if you do not have a disclosable pecuniary interest in a matter, the Members' Code of Conduct says that a member "must serve only the public interest and must never improperly confer an advantage or disadvantage on any person including yourself" and that "you must not place yourself in situations where your honesty and integrity may be questioned". What this means is that the mater of interests must be viewed within the context of the Code as a whole and regard should continue to be paid to the perception of the public.

<sup>&</sup>lt;sup>1</sup> Disclosable pecuniary interests that must be declared are not only those of the member her or himself but also those of the member's spouse, civil partner or person they are living with as husband or wife or as if they were civil partners.

### **Summary and Recommendations**

Purpose of report: To seek determination of applications received in competition for Street Trading Consent to fill a vacant approved street trading site.

### Recommendation(s):

Licensing and Registration Sub Committee is recommended to determine the three applications received and decide which applicant they wish to be granted street trading consent, in order to fill vacant approved site 18 St Giles; taking into account the details in this report and any representations made at this Sub Committee meeting.

### The Applications

- The Miscellaneous Licensing Team have received three applications for the vacant approved street trading site 18 on St Giles. The applicants are:
  - Mrs Leila & Mr Soulaiman Aidi
  - Mr Sajjad Malik
  - Mr Antonio De Jesus Neves
- 2. Full copies of each application can be found in the Appendices of this report.

### Legislative Background/Legal Framework

- 3. In 1986 the Council resolved that Schedule 4 to the local Government (Miscellaneous Provisions) Act 1982 should apply to its area. Under Schedule 4 of the Act the Council can manage street trading by designating streets as "consents streets", "licence streets" or "prohibited streets". The Sub-Committee may grant a Consent if it "thinks fit". When exercising this general power Members should only take into account relevant considerations; must give each applicant a fair hearing and should give reasons for their decision.
- 4. The Sub Committee may attach any conditions to a Consent that it considers "reasonably necessary".

### **Policy Considerations**

- 5. The Street Trading Policy was adopted by Council in July 2010 and came into force on 1<sup>st</sup> January 2011 for existing traders. Delegation is laid out in the Council's Constitution. Paragraph 5.2 of the Policy states that the Head of Environmental Development is authorised to:
  - "5.2(c) refer applications to the Licensing and Registration Sub Committee where there is competition for a vacant approve site."
- 6. Paragraph 5.4 of the Street Trading Policy states:
  - "5.4 In considering applications for the grant or renewal of a Street Trading Consent the following factors will be considered:
  - (a) Public Safety

Whether the street trading activity represents, or is likely to represent, a substantial risk to the public from the point of view of obstruction, fire hazard, unhygienic conditions or danger that may occur when a trader is accessing the site.

### (b) Public Order

Whether the street trading activity represents, or is likely to represent, a substantial risk to public order.

- (c) The Avoidance of Public Nuisance
- Whether the street trading activity represents, or is likely to represent, a substantial risk of nuisance to the public from noise or misbehaviour, particularly in residential areas.
- (d) Appearance of the stall or vehicle

The stall or vehicle must be of smart appearance and meet criteria, including size, laid down in the standard consent conditions. Photographs or sketches, including dimensions, must be provided with all new applications and requests for approval of changes to or replacement of a stall or vehicle.

### (e) Needs of the Area

The demand for the articles for sale, and the geographical location of the proposed site.

### (f) Environmental Credentials

The impact of the proposed operation on the local environment including street surfaces and materials, power supply, carbon footprint, supply chain, packaging, waste minimisation, waste disposal and waste created by customers. Mitigating measures to minimise the environmental impact of the proposed operation.

### (g) Food Traders

Applicants to trade in hot or cold food must hold a current Level 2 Food Hygiene Certificate accredited by The Chartered Institute of Environmental Health, or The Royal Society of Health, or The Royal Institute of Public Health and Hygiene.

### (h) Highway

The location and operating times will be such that the highway can be maintained in accordance with the Oxfordshire County Council's requirements and that there are no dangers to those who have a right to use the highway and no obstruction for emergency access."

### Reason for Referral to Licensing & Registration Sub Committee

- 7. This matter has been referred to Licensing & Registration Sub Committee as there is competition for the vacant street trading Site 18 St Giles.
- 8. Mrs Leila and Mr Soulaiman Aidi have applied to operate 'The Oxford Grill' Sizzler' from the vacant site. Their application is for hot and cold food, including a wide range of foods not readily available from a traditional kebab van.
- Mr Sajjad Malik has applied to operate 'Bodrum Express' from the vacant site. Mr Malik's application is for hot and cold food, including a range of cuisines.
- 10. Mr Antonio De Jesus Neves has applied to operate 'Chef's Corner' from the vacant site. Mr Neve's application is for hot and cold food, including a range of grilled meats and vegetables.

### **Financial Implications**

11. The Council collects fees for the Street Trading function. Predicted income from licence fees are included in the Council's budget.

### Legal Implications

- 12. The Sub Committee may grant a Street Trading Consent if it 'thinks fit', see paragraph 3 above. A Street Trader Cannot be said to enjoy security of tenure and there is no requirement for the Council to give compensation for the loss of any Consent (other than any refund of Consent fees paid in advance). However, any decision to refuse an application or terminate Street Trading Consents may be subject to a judicial review and if held to be unreasonable then compensation may result.
- 13. Any determination of an application for Consent must be proportionate taking into account all relevant circumstances and the Consent holder's right to a fair hearing. An application should not be refused arbitrarily and without clear reason.

### **Human Rights Act Considerations**

14. Article 6 of the European Convention on Human Rights provides that every person is entitled to a fair hearing in determination of a civil right or obligation. Applicants should be given a fair opportunity to present their case and respond to any representation against them.

### Who are you?

Leila Aidi 27 Years old and Soulaiman Aidi 34 Years old Married for 7 years with 3 children We live in Witney, Oxfordshire

### **Backround?**

### Leila

- I am currently a full time housewife
- I have been apart of the fast food business for over 12 years helping my father who trades in Woodstock road, Oxford, as a fast food street trader
- My role: Making orders with suppliers, maintaining the appearance of the van inside and out, recording daily accounts
- I have a Level 2 Food Safety in Catering certificate

### Soulaiman

- Has been working with my father in Woodstock Road since February 2005 to date.
- Has worked solely in my fathers van for periods of up to 2 months when my father has had time off for holiday etc
- Since working with my father, he has gained excellent experience and customer relations.
- His role: Check stock on daily basis, maintain appearance of himself, the mobile unit and the surrounding areas of the pitch. Adhering to the late night closing times successfully, dealing with difficult customers calmly. Giving customers quality cooked food.
- He has a Level 2 Food Safety in Catering certificate

### Our Idea

We are not changing the food range completely, as the customers are very much engaged in the general kebabs, burgers etc. Our idea is to make the food already being sold - more interesting. Soulaiman will be working 7 days a week and i will be helping on the weekends/busy periods.

### Our van

We have recently brought a motorised catering van, which will be fully equipped with stainless steel inside and top of the range equipment. My husband is a qualified mechanic and experienced in DIY. My husband will be carrying out some of the cosmetic work by himself, whilst the rest of the work including Gas/electrics is being fitted by a professional company for safety reasons..

I have enclosed photos of the van and what it will look like inside and out, once completed. The van is due to be completed within 2 months maximum

### The food

Oxfords residents and students clearly love the popular foods which are, kebabs, burgers and hotdogs, therefore, we will be keeping to these favourites by continuing to sell these foods. In addition to these regular fast food choices, we will be selling the following, to give more of a wider food range

### Types of food

- Tacos filled with many varieties such as: Chicken, minced meat, salad, falafel etc.
- A different style of battered chicken such as:
   Popcorn chicken, black pepper and coriander southern fried chicken strips, BBQ chicken wings,
   Tandori Chicken wings and Chinese marinated chicken breast fillet on a stick
- As well as the tandori masala paste used to marinate the chicken breasts found in most of the fast food vans, we will also marinate with:

  Green pesto and mayonnaise, sun dried tomato pesto, tikka masala paste and piri piri paste.

### **Drinks**

- As well as the normal tea and coffee, we will sell a wide range of other drinks such as: Bottled cranberry juice, apple and raspberry juice, orange and mango juice, apple and lime, and more
- Ranges of tea such as:

Mint tea, lemon tea and fruit flavoured teas.

• Ranges of hot chocolate such as: Hot chocolate orange, hot brazil nut chocolate, hot mint chocolate, hot chocolate raspberry and much more

### Chips

 As well as the normal sized 7/16 chips, we will be using spicy potato wedges to give an extra choice to the chip range

### **Breads**

 We will use a wide range of breads such as: Ciabatta plain/ciabatta with dried tomato and basil Garlic bread
 Onion baguette
 Garlic and plain tortilla wraps

### Sauces .

 As well as the popular sauces of ketchup, mayonnaise and houmous we will also add the following additional sauces to the menu

Guacamole Mint sauce/mint mayonnaise Tikka mayonnaise Piri piri sauce

### <u>Vegetarian</u>

• For all the vegetarians, we will have a wider range than the general falafel and veggie burger such as:

Vegetable sausages, hash browns, breaded mozzarella sticks and spicy bean burgers.

### **What Suppliers**

We have accounts set up with 4 major wholesale food suppliers. They are JJ FOOD SERVICE, BOOKERS CASH AND CARRY, PHILLIP DENNIS and N&B FOODS. Our gas suppliers are COUNTRYWIDE, which are local and are able to deliver on a daily basis.

I have ordered and collected stock from these suppliers before on behalf of my fathers business so i am very experienced in dealing with these suppliers.

### Money

From our experience in working in kebab vans, we have good knowledge of what the average weekly income and outgoings are.

- The approximate weekly outgoing which includes stock and accessories i.e. food, takeaway bags, boxes etc, would be around £1500.
- Gas is separate and the weekly outgoing for this would be around £120.
- The weekly diesel costs for the van and generator is around £180.
- The total outgoing per week on average would be £1800
- The approximate income for the week on a regular fast food van from our experience would be £2500

This leaves an approximate profit of £700p/w. This is sufficient enough to cover the quarterly council rates cost and a good profit for living expenses.

### Why us?

We have applied for a pitch from the council for many years with no success. Unfortunately, we have not been given the chance to progress our ideas in a mobile unit of our own. Although we have solely operated my fathers mobile unit on many occasions, we have been limited to sell my fathers food preferences and not our own ideas.

We have the hunger to make our additional food ideas come to reality in our own mobile unit. We think we can give oxford much more ranges of foods with that extra bit of kick.







- Street trading can only be carried out from the stall or vehicle authorised under the conditions of the consent. Any changes to or replacement of the stall or vehicle must be approved by the Head of Environmental Development.
- 6. The Consent Holder shall comply with all statutes, statutory instruments and byelaws currently in force. Consent Holders must pay particular attention to the requirements of the Health & Safety at Work Act, 1974, the Food Safety (General Food Hygiene) Regulations 1995. Advice on these requirements is available from the Environmental Health Department. The Consent Holder shall not drive or park a vehicle on any part of a footway. (It is an offence to drive other than on a road)
- 7. The Consent Holder shall not be the cause of any nuisance or annoyance to any other user of the highway, the occupier of any land or building or the Oxford City Council. Consent Holders shall have special regard to and must take positive action to prevent excessive noise.
- 8. The Environmental Protection Act 1990 places a duty of care on businesses to dispose of waste originating from their trade in a certain manner. The Consent holder shall ensure refuse originating from their trade is disposed of by a licensed waste carrier and shall leave the site clear of refuse at the completion of trading. No water or waste material shall be discharged on to the highway or any adjacent property. The Consent Holder shall ensure that the area in the vicinity of the stall/vehicle is kept clear of all refuse at all times.
- 9. Consent Holder's vehicle/stall shall be kept in a clean, safe and well maintained condition and be of a presentable appearance. The Street Trading Consent bearing the name of the consent holder shall be displayed conspicuously on the stall/vehicle so that members of the public can clearly see it during hours of business.
- 10. The Consent Holder's vehicle shall be maintained in a roadworthy condition, taxed, insured and with a current MOT Certificate.

- 11. The Consent Holder shall ensure that the stall/vehicle is positioned only in the allocated space (which may be marked on the ground) in the Consent Street for which the Street Trading Consent is issued. All goods shall be displayed on the stall and no freestanding racks or displays are permitted. If a Consent Holder or operator/assistant is requested to move the vehicle/stall by an authorised Council Officer or Police Officer they shall immediately comply with that request.
- 12. The Consent Holder's stall shall not exceed 2.3 metres in height nor occupy an area greater than 2 metres x 1 metre.
- The Consent Holder must take adequate precautions to prevent the risk of fire at the stall or vehicle. All hot food vans/trailers are required to comply with current legislation on fire safety. Where gas cylinders are used an annual gas safety certificate is required to ensure the safety of all gas cooking and heating equipment. A serviceable fire blanket and a foam fire extinguisher shall be provided in all vehicles selling hot food.
- All hot food vans/trailers are required to carry a basic first aid kit. The Consent Holder and others operators should know how to give first aid to treat victims of burns and cuts. All hot food vans should have access to a minimum of one mobile phone that must be serviceable at all times.
- 15. All staff involved in the preparation of food shall hold a current Level 2 food safety certificate that is accredited by the Chartered Institute of Environmental Health, or the Royal Society of Health, or the Royal institute of Public Health and Hygiene.
- A Street Trading Consent cannot be transferred or sold to another person except that the Consent may be transferred to a member of the Consent Holder's immediate family in the event of the Consent Holder's death or incapacity on payment of a fee. The sub letting of a pitch is prohibited.
- 17. The Consent Holder must be the principal operator and have day to day control of the stall/vehicle. The Consent Holder may employ any other person to assist in operating the stall/vehicle and shall notify the Head of Environmental Development of the name and address of that person. An administration fee will be payable.
- 18. Anyone who operates a stall/vehicle other than the Consent Holder must be authorised by the Head of Environmental Development.
- 19. A Consent Holder may terminate a Street Trading Consent by written notice to the Head of Environmental Development. A refund of the portion of the fee equal to the remaining full months will be payable, less £50 which the Council will retain to cover administrative costs.
- 20. Consent holders shall ensure that disabled people and wheelchair users can be adequately served. This may involve serving persons from outside the vehicle.

- 21. A copy of the Consent shall be carried by the operator when trading and must be produced on demand to a Council Officer or Police Officer.
- 22. Consent Holders shall have and maintain a proper insurance policy against public liability and third party risks. The minimum insurance cover shall be £10,000,000 and shall cover the operator's vehicle, or stall and any additional equipment under their control. If food is sold the insurance shall specifically include cover against food poisoning to the same amount. The insurance certificate or cover note shall be produced to the City Environmental Health Officer before the Street Trading Consent is issued. Proof of cover must be produced to an officer of Oxford City Council as required.
- 23. These general conditions, which apply to all Street Trading in Oxford, may be varied, having regard to a particular location. They are termed Special Conditions and listed on the Consent Certificate. These Special Conditions must also be complied with.
- 24. Instalments are required quarterly, in advance. On or before the following dates 1st April, 1st July. 1st October and 2nd January. Annual fees may be paid in advance.

## Failure to comply with these conditions

## **Summary and Recommendations**

Purpose of report: To consider a Street Trading Consent where the street trader has not adhered to the conditions of the Street Trading Policy.

Recommendation(s):

Committee is recommended to determine what action to take in relation to Mr Elouath's Street Trading Consent, taking into account the details in this report and any representations made at this Sub Committee meeting.

#### Legislative Background/Legal Framework

- 1. In 1986 the Council resolved that Schedule 4 to the local Government (Miscellaneous Provisions) Act 1982 should apply to its area. Under Schedule 4 of the Act the Council can manage street trading by designating streets as "consents streets", "licence streets" or "prohibited streets". The Sub Committee may grant a Consent if it "thinks fit". When exercising this general power Members should only take into account relevant considerations; must give each applicant a fair hearing and should give reasons for their decision.
- 2. The Sub-Committee may attach any conditions to a consent that it considers "reasonably necessary".

## **Policy Considerations**

- 3. The Street Trading Policy was adopted by Council in July 2010 and came into force on 1<sup>st</sup> January 2011 for existing traders. Paragraph 5.2 of the Policy states that the Head of Environmental Development is authorised to:
  - "5.2(c) refer applications to the Licensing and Registration Sub Committee where there has been a complaint about the trader of the trader has broken the conditions of their Street Trading Consent."

## Reason for Referral to Licensing & Registration Sub Committee

- 4. The Consent has been referred to the Sub-Committee in accordance with paragraph 5.2 of the Policy as Mr Elouath has failed to make payments at the agreed quarterly periods and is currently in arrears to the sum of £3,657.50. He is therefore in breach of condition 24 of the General Conditions for Annual Street Trading Consents.
  - "24 Installments are required quarterly, in advance. On or before the following dates 1st April, 1st July, 1st October and 2nd January. Annual fees may be paid in advance."
- 5. Mr Elouath signed and dated an acceptance form to agree to pay the street trading fees in 4 payments of £1,828.75 (Appendix A).
- 6. Glynis Thompson, Incomes Officer, wrote to Mr Elouath on 21<sup>st</sup> May 2012 in respect of the arrears on his account for missing his first quarterly instatement (See Appendix B) giving him 7 days to clear the account.
- 7. Samantha Howell, Licensing Officer, wrote to Mr Elouath on 22<sup>nd</sup> June 2012 in respect of the arrears on his account giving him 7 days to clear the account or revocation of Street Trading Consent would be looked at (see Appendix C).
- 8. Glynis Thompson, Incomes Officer, wrote to Mr Elouath again on 11<sup>th</sup> July 2012 in respect of arrears on his account for missing the first and second quarterly instalments giving him a further 7 days to clear the account (see Appendix D).
- 9. Mr Elouath has not responded to any correspondence from either Officer. Mr Elouath's account remains in arrears of his first two quarterly instalments amount to £3,657.50.

## **Financial Implications**

10. The Council collects fees for the Street Trading function. Predicted income from licence fees are included in the Council's budget.

## **Legal Implications**

- 11. Street trading consents may be revoked with good reason at any time. Any breach of condition, including the condition to pay the appropriate fee, may be a reason for revocation. A street trader cannot be said to enjoy security of tenure and there is no requirement for the Council to give compensation for the loss of any Consent (other than any refund of Consent fees paid in advance). However, any decision to terminate Street Trading Consents may be subject to a judicial review and if termination is held to be unreasonable then compensation may result.
- 10. Any decision to revoke a Consent or refuse a renewal application must be proportionate taking into account all relevant circumstances and the consent holder's right to a fair hearing. A Consent should not be revoked nor an application refused arbitrarily and without clear reasons.

## **Human Rights Act Considerations**

- 13. Article 1 of the first Protocol of the European Convention on Human Rights provides that every person is entitled to the peaceful enjoyment of his possessions. No one shall be deprived of his possessions except in the public interest and subject to the conditions provided for by law. However, a Street Trading Consent is not considered a possession in law and the protection in Article 1 is therefore not directly engaged.
- 14. Nevertheless, with the advice of Law & Governance and in the interests of fairness, the Licensing Officer has taken the Human Rights Act 1998 into account and considers that the potential interference with the rights of the applicant would be proportionate, in the public interest and subject to the conditions provided for by law.

## 16. APPLICATION FOR A RENEWAL OF A STREET TRADING LICENCE - MISS ARZU DE JESUS NEVES

The Head of Environmental Development submitted a report (previously circulated, now appended). Dawn Cox (Licensing Officer) presented the report to the Sub Committee.

Miss Aruzu de Jesus Neves attended the meeting and presented her case. She explained that, even though she has not been trading, she has been paying the fee for the pitch. She has attained Level 3 in Food Hygiene, will shortly have a new van, and would like to start trading again as soon as possible.

The Sub Committee resolved that its deliberations on this case should be taken in private, on the grounds that the discussions would focus on the financial and business dealings of the applicant

Miss de Jesus Neves and Licensing officers withdrew whilst the Sub Committee considered the case.

Having taken all submissions into account, both written and oral, the Sub Committee were satisfied that the Applicant had demonstrated that she was able and willing to resume trading from the pitch to which she had been allocated.

Therefore it RESOLVED to:-

- (1) Grant the renewal of the street trading licence for 1 year; but,
- (2) Delegate to officers the power to revoke the licence if the applicant is not trading to the satisfaction of Licensing officers by 30<sup>th</sup> June 1012.

Advisory comment: To ask officers to investigate the feasibility of relocating this pitch slightly.
