The Head of Community Services submitted a report detailing a case to determine the licence holder's suitability to continue to hold a Private Hire Driver's Licence in the light of a recent caution.

The Sub-Committee resolved to **take no action** in respect of the Private Hire Driver's Licence and require that any related matters come before them to allow them to reconsider the licence holder's suitability.

17. SUITABILITY TO CONTINUE TO DRIVE PRIVATE HIRE VEHICLES IN LIGHT OF RECENT RELEVANT CONVICTIONS, AND TWO OUTSTANDING COMPLAINTS

The Head of Community Services submitted a report detailing a case to determine the licence holder's suitability to continue to drive Private Hire vehicles in the light of recent criminal convictions and outstanding complaints.

The Sub-Committee resolved to **revoke** the Private Hire Driver's Licence with immediate effect and **take no action** in respect of the Private Hire Vehicle Licence.

18. SUITABILITY TO CONTINUE TO DRIVE PRIVATE HIRE VEHICLES


The Head of Community Services submitted a report detailing a case to determine the licence holder's suitability to continue to drive Private Hire vehicles in the light of an accumulation of warnings.
