Local Government (Miscellaneous Provisions) Act 1982 Street Trading - Consent Fee Arrears

Following my previous letter of 17th October 2017 regarding your Street Trading Consent fee arrears, I have been informed by our Finance Team that you have failed to pay the outstanding arrears on your account. In the letter you were given until 31st December 2017 to pay the outstanding arrears of £5,962.50. This was explained to you during our meeting in St Aldates Chambers on the 17th October 2017 when you offered me assurances that you would clear the arrears within the set time frame.

Our records show that you made a single payment of £1,000.00 on 27^{th} November 2017 but did not clear the full amount. On 1^{st} January 2018 you were invoiced for the fourth and final quarter of the fee, bringing the total outstanding Consent fee arrears on your account to **£6,950.00**.

As the arrears have not been paid the matter will now be put before General Purposes Licensing Casework Sub-Committee for consideration. In accordance with the Street Trading Policy a panel has been convened to determine what action will be taken to resolve the matter. You will be invited to explain your situation.
