Notes

1. The Member's Allowances Scheme 2015-2019 was adopted by the Council on 1 December 2014 having regard to the recommendations of an Independent Remuneration Panel, in accordance with the Local Authorities (Members' Allowances) (England) Regulations 2003. The scheme ran from 1 April 2015 to 31 March 2019 and was amended on 19 February 2018.
2. The Council has 48 councillors and the table includes payments made to a number of former councillors (local elections were held on 3 May 2018).
3. The Special Responsibility Allowance(s) column includes allowances paid to the Leader, Deputy Leaders, members of the City Executive Board, leaders of political groups, chairs of committees and panels and civic office holders.
4. A deduction was applied to the special responsibility allowances paid to Councillor S Brown to correct for an overpayment made in error in the previous year.
5. The special responsibility allowances paid to Councillor M Tidball include payments made under the maternity scheme agreed by Council on 19 February 2018.
6. The travel allowances paid to councillors C Cook, A Goff and M Tidball were agreed as reasonable adjustments for members with a temporary or permanent disability, in accordance with an amendment to the scheme agreed by Council on 19 February 2018.
7. Receipts are required for travelling and subsistence allowances.
8. The Council on 29 January 2019 adopted a new Members' Allowances Scheme to run from 1 April 2019 to 31 March 2023, having regard to the recommendations of an Independent Remuneration Panel, in accordance with the Local Authorities (Members' Allowances) (England) Regulations 2003.
