Following a restructure, this delegation is now within the
	remit of the Executive Director (Communities and People).
What decision was made?	To authorise the transfer by sale of the land at Warren Crescent to Oxford City Housing (Development) Ltd for £80,000, and purchase of the land and affordable housing at Warren crescent from Oxford City Housing (Development) Limited to the Council's Housing Revenue Account (HRA) for a consideration of £3,750,000 in total.
Purpose:	To purchase 10 homes at Warren Crescent to be wholly affordable housing (4 Social Rent and 6 Affordable Rent).
Reasons:	The decision supports the delivery of affordable housing.
	The viability appraisals undertaken show that the scheme is within the parameters set for the Housing Revenue Account.
Decision made by:	Stephen Gabriel, Executive Director of Communities and People in consultation with Councillor Linda Smith, Cabinet Member for Housing, Cllr Alex Hollingsworth, Cabinet Member for Planning and Housing Delivery; Nigel Kennedy, Head of Financial Services; and Susan Sale, Head of Law and Governance.
