Cabinet, on 13 September 2023, resolved to: Grant project approval to create a Youth Hub at Leys Pools and Leisure Centre; Recommend to Council the addition of £1,120,199 into the capital programme together with £223,907 in the revenue budget for delivery of the project; and Delegate authority to the Executive Director (Communities and People) in consultation with the Head of Financial Services / Section 151 Officer, the Head of Law and Governance / Monitoring Officer and the Cabinet Member for Leisure and Parks to award the construction contract to Oxford Direct Services Ltd subject to it being within budget and value for money. Council, on 2 October 2023, resolved to: Approve the addition of £1,120,199 into the capital programme together with £223,907 in the revenue budget for delivery of the project. The decision to enter into the construction contract falls under the authority granted to enter into the construction contract (recommendation 3 above). The decision is to enter into the Design and Build (construction) contract with Oxford Direct Services Limited (ODSL) (to create a youth hub based in the Leys Pools & Leisure Centre), to allow delivery of the development to meet the development programme and to continue to meet the funders' timescales.
	Due to the urgency to enter the Design and Build contract as set out above and to retain the funding, approval from Councillor Miles as Chair of Scrutiny was

	given on 22 November 2024 to use the urgency procedure under para. 15.17 of the Council's constitution. This enables officers to sign the contract without delay to enable works to be delivered within the requirements of the grant funding. To wait until five clear working days have elapsed to take the decision would delay the project and put the funding at risk on the basis of the funders concerns and the urgency to enter into the contract.

- d. Acquiring or disposing of leases with a rental value over £125,000 each year except statutory lease renewals under Part II of the Landlord and Tenant Act 1954.

Key decisions taken by officers may be "called in" by any four councillors or the Chair of the Scrutiny Committee within two days of the notice of decision being published.
