Introduction and background

Introduction

1. This report seeks the views of the Committee about next steps in relation to four complaints that members of the Council breached the Council's Members' Code of Conduct ("the Code") following the conclusion of an investigation by an independent investigator into those complaints.

Procedure for dealing with code of conduct complaints against councillors

- 2. The Monitoring Officer received complaints about two members of the Council relating to the meeting of the Council on 18 March 2024. The Deputy Monitoring Officer dealt with the complaints in accordance with the Council's Procedure for dealing with code of conduct complaints against councillors ("the Procedure"), which is appended to this report as Appendix 1, and consulted one of the Council's Independent Persons.
- 3. At the Assessment stage it was is established that there were valid grounds to investigate the complaints. At that stage there was no consideration or decision about whether or not there had been any breach of the Code of Conduct.
- 4. The Deputy Monitoring Officer considered that the complaints merited investigation and appointed an independent investigator and an investigation report regarding the complaints has been prepared in accordance with the Procedure and his report is appended as Appendix 2 on the exempt part of the agenda.
- 5. The Procedure requires that the Monitoring Officer will review an investigator's report and after consulting one of the Council's Independent Persons will then either seek local resolution or send the matter for local hearing before the Standards Committee.
- 6. Since the complaints relate to alleged breaches of the Code which affected the Monitoring Officer it is not considered appropriate for her to determine how the complaints should be dealt with. For this reason, the Standards Committee is asked to decide how the complaints should be disposed of. The Standards Committee is not being asked at this stage to determine whether or not the Code of Conduct was breached.
- 7. The Deputy Monitoring Officer has consulted with one of the Council's Independent Persons before bringing this report to the Committee.
