Introduction and background

- 1. The consultation "Strengthening the standards and conduct framework for local authorities in England" is an open consultation by the government. The deadline for response is 11:59pm on the 26 February.
- 2. Copies have been sent to the Independent Persons for the Council, the Group Leaders and Committee are asked if it would like to submit a response.
- 3. This consultation seeks views on introducing measures to strengthen the standards and conduct regime in England and ensure consistency of approach amongst councils investigating serious breaches of their member codes of conduct, including the introduction of the power of suspension.
- 4. Specific proposals being consulted upon for legislative change include:
 - a. the introduction of a mandatory minimum code of conduct for local authorities in England
 - a requirement that all principal authorities convene formal standards committees to make decisions on code of conduct breaches and publish the outcomes of all formal investigations.
 - c. the introduction of the power for all local authorities (including combined authorities) to suspend councillors or mayors found in serious breach of their code of conduct and, as appropriate, interim suspension for the most serious and complex cases that may involve police investigations.
 - d. a new category of disqualification for gross misconduct and those subject to a sanction of suspension more than once in a 5-year period
 - e. a role for a national body to deal with appeals.
- 5. In addition, the consultation seeks views on how to empower victims affected by councillor misconduct to come forward and what additional support would be appropriate to consider.
- 6. A copy of the consultation is at appendix 1, however it can also be accessed on line here.
- 7. Committee would be responding on behalf of the Council, though members can also comment in their own right by using the link and submitting comments online.
- 8. The Monitoring Officer has prepared her comments for Committee in Appendix to, as a guide, though it is open to the Committee to respond as it feels appropriate.

Alternative Options Considered

9. Members could respond in their own right, and no response could be submitted by Standards Committee on behalf of the Council.

Other implications

10. There are no implications arising from this report. The consultation will be followed by a response and proposed way forward from the government which, if enacted in law, will be reflected in the Council's Constitution and processes as required.
